Dr. Lewandowska leads the adult department of the GO+ lifespan learning action network (LAN) clinic associated with the Foundation of Women and Girls with Blood Disorders (FWGBD) focused on health of women and people with the potential to menstruate affected with a blood disorder, where she provides comprehensive

hematologic/gynecologic care for patients affected with a blood disorder along with Dr. Gaudreau (gynecology). She is also the director of the Hereditary Hemorrhagic Telangiectasia (HHT) Center of Excellence at IHI. Dr. Lewandowska is involved in medical education, teaching medical students, internal medicine residents, and hematology fellows. She is heavily involved in clinical research at IHI. She serves on the World Federation of Hemophilia (WFH) steering committee for gene therapy, and the WFH panel for hemostatic agents. She also serves as a member of the Medical and Scientific Advisory Council (MASAC) of the National Bleeding Disorder Foundation (NBDF).



# Hilary Gaudreau, MD



Dr. Hilary Gaudreau is an obstetrician gynecologist with expertise in providing reproductive healthcare for women and people with the potential to menstruate who have an underlying hematologic disorder. Dr. Gaudreau extends this expertise to IHTC's GO+ LAN Clinic, the only specialty clinic of its kind in the state of Indiana. Dr. Gaudreau addresses reproductive healthcare concerns throughout adulthood, using shared decision making with her patients to guide safe treatment plans for conditions ranging from heavy or dysfunctional uterine bleeding to menopause/perimenopause. She is involved in medical education of obstetrics/gynecology residents and hematology fellows who rotate through the GO+ clinic. Dr. Gaudreau has served as a

speaker and educator on reproductive health for physicians and patients throughout the state of Indiana, including Indiana State Department of Health's Labor of Love, Hemophilia of Indiana's state and regional meetings, hospital grand rounds, and physician association meetings.
